



Anti-Ragging Policy

1. Preamble

CSSR & SRRM Degree & PG College Autonomous, Kamalapuram is committed to providing a safe, respectful, and healthy learning environment for all students. Ragging in any form is strictly prohibited, and this policy is adopted to comply with the **UGC Regulations on Curbing the Menace of Ragging, 2009 (and subsequent amendments)**.

2. Objective

To eliminate ragging in all its forms in the institution by strictly prohibiting any conduct that constitutes ragging, ensuring prevention, prohibition, and punitive action in accordance with the UGC Regulations and applicable law.

3. Definition of Ragging

Ragging includes any act by a student or group of students that causes, or is likely to cause, physical or psychological harm or apprehension, injury, embarrassment, harassment, or ridicule to any student. It covers:

- Teasing, amusing, or playing practical jokes
- Abusive gestures and comments
- Verbal abuse, including derogatory remarks
- Physical assault or threat
- Sexual harassment
- Unwelcome conduct that affects mental health
- Hazing of any nature

(As defined in UGC Regulations)

4. Scope

This policy applies to all students, faculty, staff, and any person present on campus or at college activities (academic, sports, cultural, field trips, transportation, or online interactions).

5. Anti-Ragging Committee

An Anti-Ragging Committee shall be constituted by the principal with representatives from faculty, administration, students, legal advisors, and parents to:

- Monitor implementation of the policy
- Inquire into allegations of ragging
- Recommend actions for prevention and redressal
- Coordinate with local authorities and police when required

6. Anti-Ragging Squad

An Anti-Ragging Squad of faculty and students will:

- Conduct surprise inspections in hostels, classrooms, common areas
- Identify hotspots of potential ragging
- Report incidents to the Anti-Ragging Committee

7. Student Undertaking

All students (fresh and existing) must submit a **mandatory anti-ragging undertaking** at the time of admission as per UGC format, stating they:

- Will not participate in ragging
- Will report any act of ragging
- Understand punitive actions in case of violation

8. Reporting Mechanism

Students can report incidents through:

- Dedicated helpline / email
- Complaint box at the Administration Office
- Direct report to Anti-Ragging Committee/Squad members

9. Confidentiality and Protection

- Identity of complainants and witnesses will be kept confidential.
- No adverse action will be taken against students reporting in good faith.

10. Action and Penalties

On finding evidence of ragging, the Committee may recommend one or more penalties, including but not limited to:

- **Expulsion or rustication** from college
- **Withholding admission/registration**
- **Fines and community service**

- **Suspension**
- **Cancellation of scholarship**
- **Recommendation for criminal prosecution**

The institution shall act in compliance with:

- UGC Regulations on Curbing the Menace of Ragging
- Indian Penal Code (relevant sections)
- State anti-ragging laws

11. Awareness and Prevention

The College shall regularly organize:

- Workshops on anti-ragging and student rights
- Orientation sessions for freshers and seniors
- Posters, circulars, and digital campaigns promoting dignified conduct

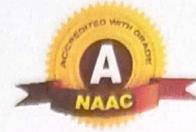
12. Review and Amendment

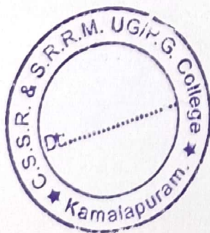
