


In this context, I am to send enclosed the list of conditions stipulated by the Inspection Commission, G.O.Ms.No.208, dated 21.8.90, No.1623, dated 12.10.90 and to request you kindly to take necessary steps for fulfilling the conditions stipulated by the Inspection Commission and other general conditions stipulated in the Laws of the University and the State Government in its G.O's issued from time to time.

The College should follow the recommendations made by the Inspection Commission scrupulously and submit the compliance report to the University soon after fulfilling all the conditions suggested by the Commission and the State Government, so as to enable the University to send another Inspection Commission for verification and report before granting extension of affiliation for the next year.

Further, I am to inform you that the Management of the College has to deposit a sum of Rs.25,000/- (Rupees Twenty five thousands only) in the joint names of the Registrar, S.V.University, Tirupati and the Correspondent of your college as III Instalment of corpus fund for third year and also to deposit a sum of Rs.2.50 lakhs (Rupees Two lakhs and fifty thousands only) to the Government as III Instalment towards the corpus fund for the third year as per the G.O.Ms.No.1623, dated 12.10.90.
